Swimmer's Commitment:

AS A PEBBLE CREEK SWIMMER:

1. I MUST be able to swim the length of the pool without assistance (i.e. wall, bottom, lane line) by the second meet.
2. I am expected to attend practice daily and promptly. If I find that I cannot attend practice for a legitimate reason (i.e. summer school, job, vacation, camp, doctor's appointment, illness) I will let the coach know and, if possible, arrange to make it up.
3. I will notify my coach at the start of the season of any medical conditions that he/she should know about, concerning my well-being, including but not limited to diabetes, asthma, and allergies.
4. I understand that if I decide to no longer participate in the practices or meets of the swim team program that I will not be eligible to receive a refund of any fees paid to the program. *Any refund of fees due to medical or other situations will be considered by the Board.*
5. I will remain in the pool area during practice sessions. If it should become necessary for me to leave practice, it is my responsibility to notify the coach.
6. I will conduct myself in a way that will not disturb others or violate established rules of conduct (as outlined by the coach and the Pebble Creek Pool Committee) during practice sessions and before, during, and after the meets.
7. I understand that if I am suspended from the pool for any reason, I will not be able to swim with the team during the time of suspension.
8. I understand that should my behavior present a continuing problem, I may be asked to leave the team or will not be permitted to swim in the next meet. This will be decided by the coach and the Board, and fees will not be refunded.
9. I will listen carefully to my coach's instructions at all times, particularly when safety is concerned.
10. On meet days, I will make every effort to arrive at the meet on time, rested, and ready to do my best.
11. I understand that if I treat the coaches, the parents, and the volunteers with respect I can expect to be treated accordingly.
12. I will practice good sportsmanship by the following:
 - After meet warm-ups, I will stay in the general area designated by the coach so that the team can return to the waiting area as a unit.
 - I will participate in the team cheers and go to every meet with a winning attitude.
 - When I finish my race, I will stay in the water until everyone is finished the race, and I will shake my opponent's hand win or lose.
 - I will watch other events and cheer on my fellow teammates.
13. I will not bother the coaches or judges during the meet unless it is absolutely necessary and will direct all initial inquiries to the Parent Rep.

AS A PEBBLE CREEK SWIM TEAM SENIOR SWIMMER:

As an "older" swimmer, I will be expected to serve as a model of good behavior for younger swimmers, and to help maintain order during practices and meets. I will show, through my leadership and attitude, good sportsmanship and a positive competitive spirit.

Parents' Commitment:

The Pebble Creek Swim Club is a volunteer organization run by the residents of the Community and parents of the swimmers. It is imperative that each parent volunteer to participate at home and away meets as requested or as needed in order for the swimmers to get the most out of this experience.

AS A PEBBLE CREEK SWIM TEAM PARENT AND VOLUNTEER:

1. I understand that my child **MUST** be able to swim the length of the pool without assistance (i.e. wall, bottom, lane line) by the second meet or s/he is ineligible for the swim team. Refunds are generally not available but will be decided by the board in emergency situations.
2. I am expected to volunteer my time in support of the team. This will involve helping at meets in some capacity and perhaps participating in appropriate training as needed in accordance with GRAL regulations. I understand that my household must sign up for at least 5 volunteer slots and that if I do not fulfill my volunteer requirements, my child may not swim in the meets.
3. My family is required to bring an item, as requested by the Concessions Coordinator (Lucy Perkins), to each home meet. I will sign up for the items I want to bring at registration. I must bring the specific item I am assigned if my child is to swim that night. If I am not attending the meet, I must have someone else bring the item in my place.
4. I will endeavor to see that my children abide by the Swimmer's Expectations as stated on the previous page.
5. I understand that should my child's behavior present a continuing problem, or should he/she fail to fulfill his/her commitment, after efforts by myself and the coach to resolve the difficulties, he/she may be asked to leave the team and not compete in the next or future swim meets. The registration fee will not be refunded.
6. I understand that I may contact any member of the Board or the Parent Representative should I have a question, concern, or grievance concerning the swim team program.
7. If my child will be missing a swim meet, I will let the Computer Rep (Christy Evanko) know **at least two days in advance**.
8. I will address any concerns or issues with the coaches before or after practice – not during.
9. I understand that I must check to see if my child is swimming in a relay **before taking my child home**. Relay compositions change frequently and are not communicated before the meet.
10. I will not communicate with the coaches during the meets, but will instead, if necessary, contact the Parent Representative (Pam Hill).
11. I will clean up my area at both home and away meets.
12. I will set a good example for my child and others with my good sportsmanship.
13. I attest that I notified PCST (via the check box on the registration form) if my child swam competitively on a team other than Pebble Creek (or high school) since 6/1/09. PCST could be subject to a fine if the information is false and that fine may be passed along to me.
14. I agree to have my name and phone number printed on a team roster for distribution to members of the team and PCST administrative personnel only.
15. I agree to allow pictures taken of my child to be posted on the team Web site: www.pebblecreekswimteam.com unless the box is checked on the form. Names will not be associated with pictures on the site.
16. I understand that in order for my child to swim, my household must be a member *in good standing* of the Pebble Creek Pool. All household dues and fees must be paid and all swimmers must have verifiable access to the pool in order to be registered.

Agreement:

The undersigned (see signature at bottom of form) hereby agree(s) as a condition of participating in the Pebble Creek Swim Club (PCSC) to: (A) abide by and adhere to all of the Pebble Creek Property Owners' Association (PCPOA) rules and regulations, (B) acknowledge that the use of the swimming pool can be potentially dangerous. I/We hereby agree that we are responsible for our own behavior, as well as that of our children. I/We consent to emergency medical care in the event that it shall be required in connection with the use of the facility. Further I/We hold PCSC, its Coaches, the PCSC Board, and PCPOA harmless from all reasonable costs and expenses, including attorney's fees incurred by PCSC, Coaches, Board and PCPOA as a result of any claim or suit brought by or on behalf of the undersigned or a family member of the undersigned, the outcome of which is a determination or agreement that PCSC, Coaches, Board and PCPOA are not liable.
